Please note that these items must be received at least 7 business days prior to the date of the event.

NOTE: All laws and requirements relating to the sale of alcoholic beverages must be complied with. It is understood that the person names herein is in charge and responsible for the event, and all officers of the organization may be held liable and responsible for any violation of law or regulation. Georgia Sales Tax must be remitted to the State on all Sales of this event. If the organization does not hold a Georgia State Tax number, the organization must file for a DOR Wine Tasting Permit.
