When the bond payment is secured, we will instantly send notification by fax and/or email to the facility's bonding/release department. Introduction

Cash Bond Online, Inc. provides a fast, secure and free online cash bond payment option for Law Enforcement and Government Agencies. The payment service enables family / friends to post cash bonds online with a credit or debit card, allowing them to avoid the inconvenient and cumbersome in-person process.

Agency Interface

Agency Interface - Cash Bond Online Inc. receives a data file containing the same information that your staff enters into your inmate management system. This information is updated every 10 to 15 minutes, Cash Bond Online has no ability to alter or edit this transferred data in any fashion, so in short, If there is any mistake on our website that pertains to your data, please understand that all of our information is sent directly from your jail management data..

General Information- The public may access the system through the Cash Bond Online website (www.cashbondonline.com) or through a toll-free number (888-726-6301). Secure transactions are completed in minutes. Our customer service representatives are available to assist end users 24 hours a day, 7 days a week. The system is implemented at no cost to the tax payers and is subsidized by a small convenience charge that is applied to the end user. Whether using the website or the toll-free number, the public is able to pay a cash bond around the clock, which means constituents will always be able to help their loved ones who need assistance.

Cash Bond Online combines the information that has been received from your system, with the information gathered from the Surety, to create your required release paperwork. Cash Bond Online customizes this process according to your standards and requirements. The customization process is not complete until the cash bond online calculations and bond paperwork, meet or exceed your requirements. Once the cash bond payment is secured, Cash Bond Online will instantly send notification by fax and/or email to the facility's bonding/release department. We guarantee payment, upon your facility receiving notification that the detainee is eligible for release. Bond payment is transferred by wire or ACH (Automated Clearing House) to the account designated by the governmental entity

 - d. The courts that can use your cash bond online service
 - e. The Jail Booking Area
 - f. The inmate cell areas
 - g. Your inmate phone system should allow free calls to your Cash Bond Online toll free call center, please be aware that it can take up to 15 minutes to process the bond via the call center.
 - h. Inmate handbook

NOTE: please contact their inmate phone provider and ask that phones in booking allow calls to our 800 number and they be made free.

SERVICE AGREEMENT

THIS SERVICE AGREEMENT (the "Agreement") is made and entered into this ___ day of _____, 20____, by and between **CASH BOND ONLINE, LLC** ("Company"), a Georgia company having principal offices at 1960 Satellite Blvd., Suite 3000, Duluth, Georgia, 30097, Attn: Lee A. Harris, Vice President, and the _____ a governmental agency having principal office at _____; Attn: _____

Statement of Agreement

NOW, THEREFORE, in consideration of the mutual agreements, representations, warranties and covenants set forth herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Company and Agency hereby agree as follows: Company is in the business of providing, among other things, online cash bond payment processing services to its clients through its website, www.cashbondonline.com (the "Site"). Agency desires to engage Company, and Company desires to accept such engagement, to provide such services to persons acting as surety for Agency inmates ("Users"), all on the terms and conditions set forth herein.

1. **Engagement.** Agency hereby retains Company, on a non-exclusive basis, to provide to Agency, its inmates and Users, those online cash bond payment processing services.

2. **Consideration.** The Services shall be provided to Agency without any charge to Agency or its governing entity therefor; provided, however, that Company may charge Users of the Site and the services provided thereon processing fees. As between the parties, Company shall assume all risks of collection and payment disputes pertaining to the cash bonds processed via the Services.

3. **Confidentiality; Intellectual Property.**

(a) Company retains all title and ownership to all intellectual property rights, including without limitation, design, trade secrets, know-how, patent rights, trademarks, service marks and copyrights in and to the Site and Services, Confidential Information, and any derivative works thereof (collectively, the "Intellectual Property"). Agency waives any and all claims to title and ownership of the Intellectual Property.

4. **Representations and Warranties; Disclaimers.**

(a) Each party represents and warrants to the other party that: (i) it has no obligations, legal or otherwise, inconsistent with the terms of this Agreement or the relationship created by this Agreement; and (ii) it has the necessary right and authority to enter into, and perform the obligations set forth in, this Agreement.

5. **Limitations of Liability.** IN NO EVENT WILL COMPANY'S LIABILITY UNDER THIS AGREEMENT EXCEED THE BOND AMOUNT.

6. **Term and Termination.** The term of this Agreement shall commence on the date first set forth above, shall continue for one (1) year, and shall renew for successive periods of one (1) year. However, Agency may terminate this Agreement at any time, without cause, upon ten (10) days prior written notice to Company.

7. **Miscellaneous.** This Agreement shall be governed by and construed in accordance with the laws of the State of Georgia without regard to its rules governing conflicts of law.
